- 2. Further, in view of above, the visitation report and all other related documents were assessed in terms of enforced regulation namely the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", "Indian Medicine Central Council (Requirements of Minimum Standard for post-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", and provisions under the NCISM Act, 2020 and relevant Regulations there under, and on the basis of Relaxation policy issued by the NCISM dated 16.03.2022. On careful examination of the assessment report it was found that your college is not fulfilling the notified & approved criteria for issuing of Conditional permission with 60 seats in UG (BAMS) Course and 15 seats in 04 PG Course i) Ayurved Samhita Siddhanta- 03 seats ii) Rachna Sharir-06 Seats iii) Kayachikitsa- 03 seats iv) Rog Nidan evam Vikiriti Vigyan- 03 seats under section 28 of the NCISM Act, 2020 for the academic session 2022-23 and Board decided to provide an opportunity of hearing to your college. Thereafter, an opportunity of hearing was granted to your college on 30.11.2022 to present the case through virtual mode.
- 4. The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", "Indian Medicine Central Council (Requirements of Minimum Standard for post-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020 and relevant regulations thereunder, and once again as per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the recommendation of Hearing Committee was placed in the 22nd Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) on 02.12.2022. 



The College authorities may take up the matter for recognition of the qualifications under Section 14(2) of IMCC Act, 1970 at the time the first batch admitted for the above courses appears for the final year examination. There does not appear to be any necessity or legal requirement to grant permission from year to year for the newly permitted PG courses as mentioned above, till the same is withdrawn as per the provisions of the IMCC Act, 1970.
